

## **WESTERN RIVERINA LIBRARIES APP PROMOTION**

### Terms and Conditions

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions and any entry not complying with these Terms and Conditions is invalid.
2. Entry is open to Australian residents ages 12 and over. Employees of the 'Promoter' (Griffith City Council) and their immediate families are ineligible to enter. Employees of the 'Western Riverina Libraries Member Councils' and their immediate families are also ineligible to enter.
3. Promotion commences at 00:01AM Australian Eastern Daylight Time ("AEDT") on August 1, 2021 and closes at 23:59PM AEDT on October 31, 2021 ("Promotion Period").
4. To enter, entrants must:
  1. If not already, register as a Western Riverina Libraries member.
  2. Download the Western Riverina Libraries App
  3. Login into their member account.
5. Entrants may enter the competition only once. Additional entries by the same individual will be discarded.
